Dear Mr. Governor,

Downtown STL, Inc., a business organization within the region's core, wishes to share with you our concerns about the St. Louis Community Release Center (Release Center) at 1621 N. 1st Street, St. Louis, MO 63102. The Release Center is operated by the Missouri Department of Corrections and has been the source of many serious problems in both the area immediately adjacent to the facility as well as the broader Downtown community.

The Release Center allows residents to be released throughout the Downtown area on a daily basis with minimal supervision. These residents frequently travel throughout Downtown aggressively begging and attempting to procure drugs. Discussion with residents at the facility indicates that drug problems run rampant within the facility.

The Release Center is located within blocks of the financial center of St. Louis. Businesses in Downtown, as well as employees of these businesses, indicate that this facility leads to many problems in the area. We have attached to this letter, a few examples of aggressive crimes committed by individuals staying at the Release Center during their unsupervised time. These incidents include violent assaults of business people in Downtown. The attached incidents are jarring, but are no doubt underreported. The St. Louis Metropolitan Police Department indicates that residents of the facility will often give incorrect address information upon arrest, leading to significant underreporting.

We as an organization, as well as the various business leaders and organizations accounted for in the signature block below, feel that this facility must be closed for the good of the region. The location of the facility both limits development to the riverfront as well as Downtown and makes current businesses uncomfortable with the safety of their locations. We believe strongly that the facility is costing the City of St. Louis incalculable financial damage and is potentially an impediment to new development, as the result of safety concerns within a multi-mile radius of the facility.

Mr. Governor, we humbly request as leaders of the St. Louis business community, that you seriously consider closing this ineffectual facility.
